

essentials that would bring the standard of care into 2019 and beyond. This expansion will increase the square footage from 7,000 square feet to 14,700 square feet, improving accessibility, privacy and patient comfort and care.

### Paying it Forward for Patient Comfort

The Saint John Regional Hospital Auxiliary's Brighten Group is In the past five years alone, more than \$500,000 has benefitted all about Paying it Forward for patient comfort. For 100 years, those who need our attention most. Its legacy may be measured it has been focused on continued care, compassion and creative in years and donations, but it is also seen on the faces of patients contributions to the health of New Brunswickers. and their families in our hospital every day.

In the aftermath of WWI, 74 Saint John women brought imagination and initiative to the General Public Hospital with the Women's Hospital Aid Association, "not for personal gain, but for public service." While the General is but a memory, the Auxiliary remains resilient and relevant a century later.

One project benefitting from the good work of the Brighten Group this year is the "Home Away from Home" Patient Hostel. \$100,000 dollars was donated to renovate the space to make it feel a little more like home.

### Studies of Prehab, for Less Rehab

Thanks to a new study and a generous donation from The McCain Foundation, spine surgery patients could be feeling better, quicker.

The idea is that many spine surgery patients would benefit from a cardiac "prehabilitation" program, where education, physiotherapy and physical activities BEFORE spinal surgery can significantly improve patient outcomes. They will be healthier going into the operation, should be healthier after the operation, and then, in turn, stay healthier longer.

"Ultimately, surgery is like marathon running," says Dr. Neil Manson. "And the fitter you are going into the marathon, the less it's going to hurt, and the better you're going to do. So it makes sense.


This study is happening because of 75,000 dollars from The McCain Foundation.


