The first months of 2020 have been difficult for our community. With our offices embedded in the Saint John Regional Hospital, we feel the challenges you as patients, you as family members, you as healthcare professionals and you as donors are facing.

And it's that first-hand experience that encourages us to keep doing what we do.

### **It inspires us. YOU inspire us.**

Much good work has taken place over the past year, thanks to your support. Some of that work was planned months and years in advance, some, mere weeks.

But no matter the timeline, the result is better healthcare for New Brunswickers.

We are excited to enter the final year of our GIVE: Clinic 1 Expansion Campaign. This will be transformative, not only for the busiest clinic in the hospital, but for the entire hospital overall.

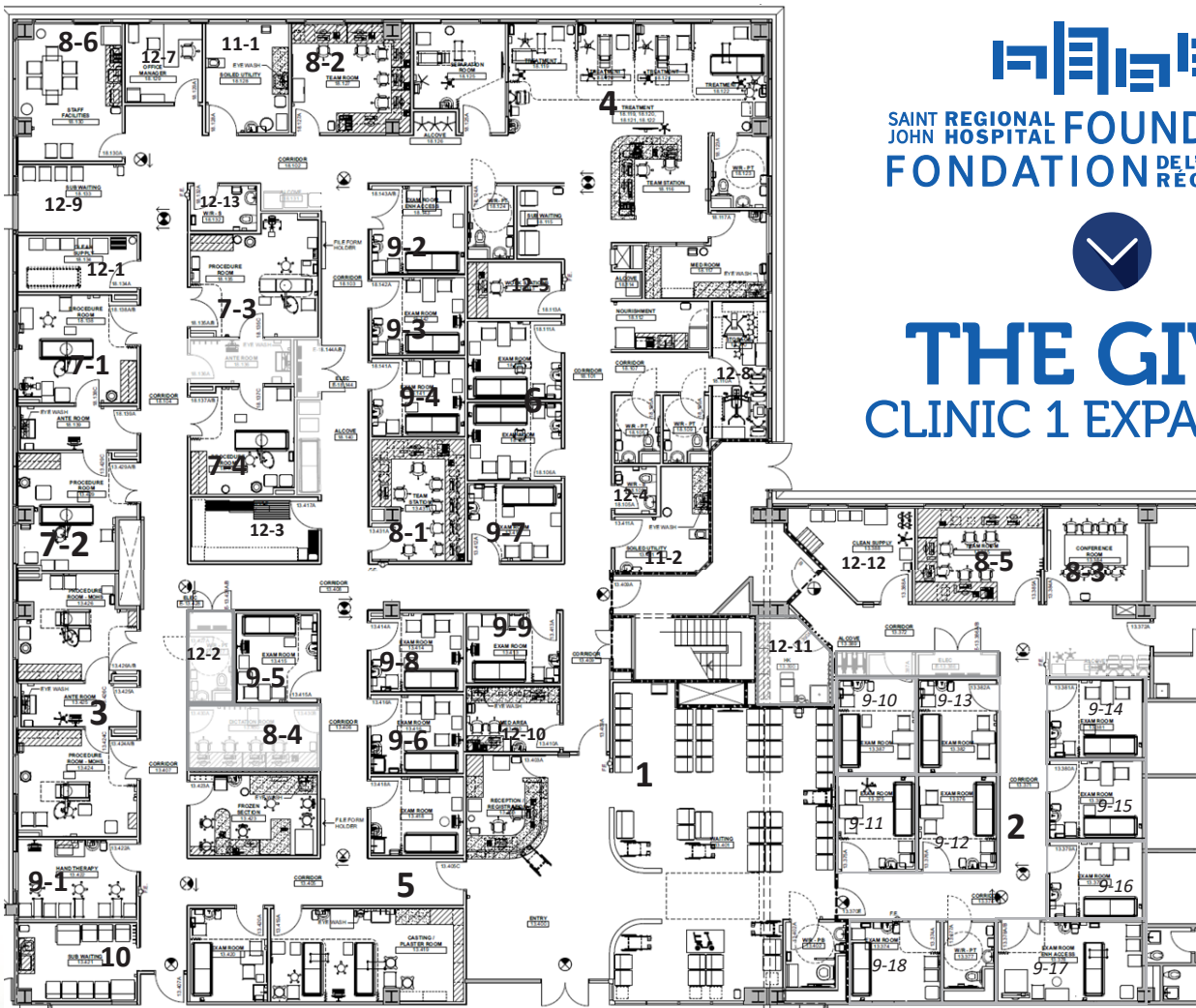
